In case of any dispute, the Qatar Laws are applicable only.

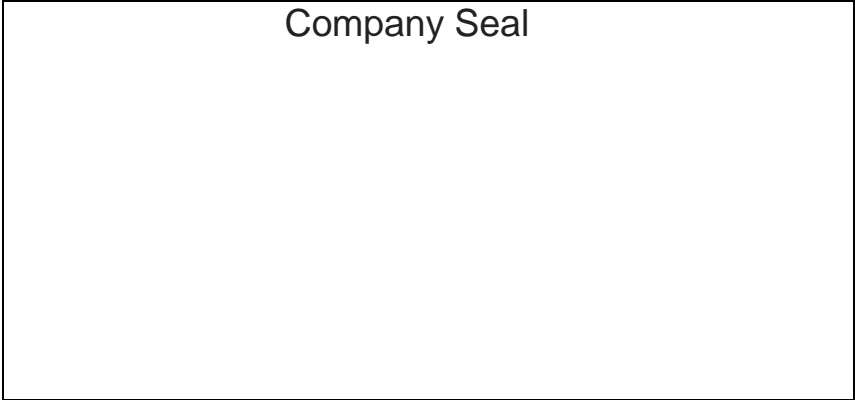
